1. Admissions 2025/26

The SHINE Multi Academy Trust (SHINE) came into being on 1st December 2016 and is the admission authority for Ironville and Codnor Park Primary School, John Hunt Academy, Langold Dycarr Community School, Ranskill Primary School, Scotholme Primary and Nursery School and Whitemoor Academy (Primary and Nursery). As a Multi-Academy Trust, SHINE are required to consult on our admission arrangements¹ and trustees have determined that all academies within the Trust will work in partnership with their home local authority admissions team and subscribe to their service offer (as available).

Note: Applications from parents/carers must be made on the relevant online or paper Common Application Form (CAF) available from the home local authority where they are resident, even if the school is located in another local authority area. Should a CAF be submitted to a LA where the parent/carer is not resident, the parent/carer will be advised to apply directly to their home authority. The local authorities are then responsible for liaising with each other to coordinate the scheme across local authority boundaries.

6.1 Any child refused a place at an academy within SHINE has a right of appeal to an independent appeals panel, established by the admission authority for that academy, i.e. SHINE, and formed in accordance with the DfE School Admission Appeals Code.

6.2 When an application for a place at John Hunt, Langold or Ranskill is unsuccessful, parent/carers are able to appeal the decision by completing this admissions appeals form:
